

- iii. *In case an MOD, in dire need, avails any sort of leave, he/she shall mention in his/her application, about the fact that he/she is also the MOD. He/she shall not leave the station unless the leave so applied for, is granted and the alternate MOD is notified by this office.*
- iv. *The successor in court in case of transfer of any of the abovementioned officers shall automatically perform the MOD duty assigned to his/her predecessor in the above table.*
